CIRCULAR

SUB : Courts - Criminal Courts - Special attention of the Presiding Officers while forwarding material part of the records to the High Court - instruction already issued - Further reminder issued - Reg.

16/2/2005

REF : High Court's Circular dated 14.08.2002 and 23.11.2004 in H.O.C. NO. 89/2002/CRL. SEC.

The High Court, in the course of hearing of Criminal Appeals, had been put into much inconvenience for want of certain material records from the Trial Court, particularly the written statement filed by certain accused in the course of the proceedings u/s. 313 of Cr.P.C.

This Court by Circular dated 14.08.2002 and 23.11.2004 under the references cited, have already instructed all the Presiding officers to take more attention in sending all the important material parts of records such as, FIR, Judgment of Trial Courts, Charge Sheet, Statement of the Accused, Charges framed by the Courts, Deposition of the Prosecution Side and connected Exhibits, Statement U/s. 313 and Written Statement of the Accused if any filed U/s. 313 Cr.P.C., the Deposition of the Defence Side and Exhibits filed by the Defence Side and any other relevant records.

Therefore, the Trial Courts/Criminal Courts are required to transmit the entire records to the High Court for hearing of the Criminal Appeals/Proceedings including the written statement of Accused filed along with 313 Cr.P.C. statement without fail and the Presiding officers and the Principal Sessions Judges are required to monitor the same so as to avoid any inconvenience to the Hon'ble High Court in the course of hearing of criminal Appeals.

The Presiding Officers of the Trial Courts are also instructed to forward immediately the Written Statement of the Accused filed along with 313 Cr.P.C. Statement, if any, if not already submitted, while submitting the material part of records to this Registry as well as to the Registry of the Madurai Bench of the Madras High Court as per the Jurisdiction, for reference in Criminal Appeals.

The receipt of the Circular is required to be acknowledged.
